2	Question:	Are specialty law firms used?
	Answer:	Summit Law Group out of Seattle is currently used for labor relations matters
		on an as needed basis.

		assist in legal matters.
3	Question:	Why is the procurement for general legal services contract being released at this time?
	Answer:	The resulting contract will replace our existing general legal services contract which is scheduled to expire on March 31, 2018.
4	Question:	Will your existing firm be submitting a response?
	Answer:	Our existing firm is welcome to submit a response.
5	Question:	Section 8, item 5 – Please clarify the "fixed-fee" term reference and how this
		needs to be addressed in the submittal.
	Answer:	The work performed under this contract is to be based on agreed hourly

	Sample Contract: Section 8, Item 5 is to be replaced with the following: A. Payments for services provided hereunder shall be made following the performance of such service, unless otherwise permitted by law and approved in writing by Transit. No payment shall be made for any service rendered by Legal Counsel except for services identified and set forth in this Agreement.
	B. Transit shall pay Legal Counsel for work performed under this Agreement compensation as described in Appendix B, Price Agreement.
	C. Legal Counsel shall submit to Transit, on forms approved by Transit, an invoice of services rendered during each pay period. Transit shall initiate authorization for payment after receipt of an approved invoice and shall make payment to Legal Counsel within approximately 30 days thereafter.

6	Question:	Section 3.1 – Is legal representation required in person at Transit Authority
		meetings that are scheduled on the first and third Wednesday of the month?
	Answer:	Transit requires in-person legal representation on the first Wednesday of the
		month. Legal representation may be required on the third Wednesday.

7	Question:	Section 7.5 – Are we limited to two pages for each area or two pages for the entire response of 7.5A?
	Answer:	In this section, we are seeking resumes as part of the response and recognize that two pages may not be sufficient. Accordingly, the two page limitation will not apply to resumes. The intent of limiting pages is to promote clear and concise responses.

8	Question:	Section 7.3C – Asks for several registration numbers. Would just a WA State
		UBI Number suffice?
	Answer:	The intent of this section is to ensure firms are currently registered in
		Washington to perform the services proposed. If a specific registration is not required for the work proposed, firms should note that it is not applicable
		(NA).
