What is What Moves You 2045?

The plan is our regional roadmap for a complete and high-functioning transportation system over the next 25 years

Why do we do this plan?

- Roads don't know boundaries - transportation needs to work as a cohesive system, without dramatic changes across jurisdictions.
- Transportation, land use, and economic prosperity are closely linked and need both a local and a regional viewpoint.
- Maximizing the benefits of all transportation modes (transit, cycling, walking, personal vehicles) is most efficiently accomplished at a regional scale



Digging a little deeper...

What's in the plan?

- 20 year planning horizon
- All transportation modes (transit, cycling, walking, personal vehicles, freight vehicles)
- Consider transportation technology
- Preserve existing system
- Model future travel demand
- Identify projects and strategies
- Reflect countywide planning policies
- Be financially feasible
- Use performance measures
- Promote public involvement
- Preserve the region's environment





Areas of emphasis

- Maintain the system we've already invested in
- Correct fish passage barriers
- Continue to enhance transit options
- Emphasize system efficiency (e.g., travel and commute trip demand, transportation technologies)
- Strategic system expansion (e.g., road connections, bike lanes and trails...)
- Plan for local and state roads as a cohesive system
