What is a Capital Improvement Plan?

- 5-year framework of our capital investments needs
- Updated annually
- Foundation to support the Transportation Development Plan (TDP), the Transportation Improvement Program (TIP) and collaborates with the Strategic Plan in providing services



Why do a Capital Improvement Plan (CIP)?

- Anticipate needs rather than reacting to problems of the moment
- Provides cashflow forecasting over several years
- Positions Intercity for grant opportunities
- Provides the ability to evaluate competing demands for resources
- Informs the public about the government's future investment in infrastructure
