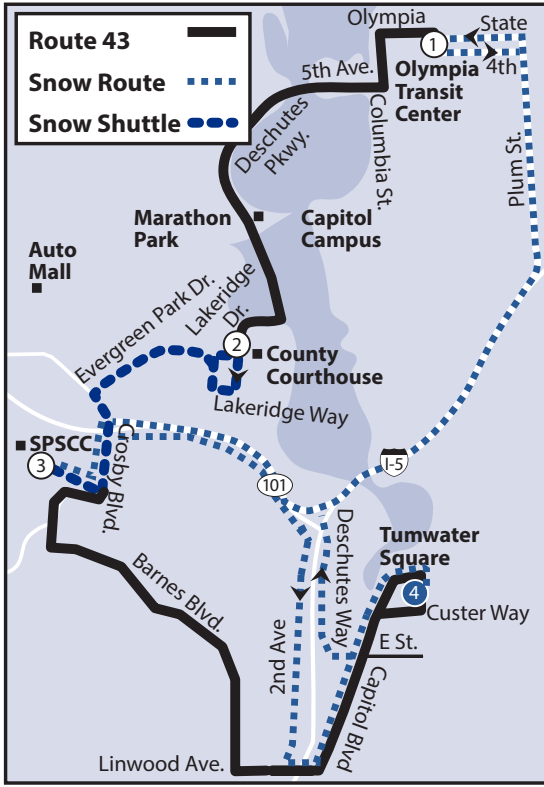


Route 43 Snow Detour



If Lakeridge Drive is closed, the bus will service SPSCC via I-5 and Highway 101. Shuttle service will be provided between SPSCC and the Thurston County Courthouse and vicinity. If Barnes Boulevard over Tumwater Hill is impassable, the bus will follow Highway 101, 2nd Ave., Linwood Ave., Capitol Blvd., E St. to Deschutes Way and Highway 101 to SPSCC. If the Crosby entrance to SPSCC is closed, service will be to SPSCC's Mottman Rd. entrance.
